

### **Donate Blood, Save Lives**

Personal Lines agent John O'Brien was recently coming out of church with his family and stopped in to the Big Red Bus for a blood donation. John tries to donate as often as he can. Not only does his donation produce a universal blood type, but he has what is sometimes called "Babies' Blood". Most adults at some point in their life are exposed to the Cytomegalovirus, or CMV. Only about 11% of the donors test negative for CMV, so John's universal, CMV negative blood is sent off for pediatric transfusion.

The machine separates the components, keeping the red cells and returning the rest with an added sterile saline solution to make up for volume. To the donor's delight... through a smaller needle than whole blood donation!




