### Social Security: One Size Doesn't Fit All

Whether you are married, divorced or are a surviving spouse, when and how you take your benefits can dramatically impact your bottom line. In a 2012 report issued by Prudential Financial, it was revealed that many Americans are missing out on the full benefits of Social Security. - A divorced spouse becomes eligible for spousal benefits as soon as your former spouse becomes eligible, if you have been divorced for at least two years.
- If you are divorced and your former spouse passes away, you may be eligible to step into a survivor benefit if it is higher than your own.
- If you are widowed, you have several options, including taking the survivor benefit at age 60, and switching to your own worker benefit at age 62 or later.

Today's retirement income climate is all about choices. Employing a strategy that helps you avoid common pitfalls and costly mistakes may help you maximize your lifetime Social Security benefits. While many of the options can seem confusing, understanding and evaluating your available choices and selecting Social Security claiming strategies that best suit your specific financial needs is an important step to building financial security in retirement. #### CHECK THE SECURITY OF YOUR GOOGLE ACCOUNT

Google has a free service called, Google Security Checkup, that allows you to easily and quickly check the security of your Google accounts. Performing a security check is able to help you find any problems that may exist. It takes just a couple of minutes. Here's what it does:

1) Ensures your account recovery information is current.

If Google detects suspicious activity in your account, they use this recovery information to get in touch with you to make sure no one, but you, gains access to your account.

2) Lets you review recent sign-in activity.

Reviewing recent activity allows you to validate that the sign-ins are coming from you and not someone who should not be using your credentials.

3) Confirms the applications and devices that you have given permission to access some of your Google account information.

This step lets you see other applications and services you've given permission to access your account information. You can remove apps and devices that no longer need access.

The Google Security Checkup is free, and you can run the process by going to https://myaccount.google.com/ and clicking on GET STARTED.

#### **Baked Strawberry French Toast**

#### **Ingredients:**

- 1 loaf day old bread, sliced into 3/4" thick slices
- 1 cup strawberries, hulled and sliced
- 4 eggs
- 3 1/2 cups milk
- 3 teaspoons sugar
- 1 teaspoon salt
- 2 teaspoons fresh grated nutmeg

Zest of 1 lemon

1 tablespoon vanilla extract

#### Directions:

Butter 9X13 baking pan. Arrange bread slices so they overlap. Tuck strawberries between the slices.

In a medium bowl, lightly beat the eggs. Whisk in the milk, sugar, salt, nutmeg, lemon zest, and vanilla. Pour over the bread. Make sure all slices are just about covered by the egg mixture.

Bake in oven for 40-45 minutes at 350 degrees. Serve with maple syrup and more strawberries!


